## RoHS and REACH Compliance Declaration (June 2020)

Dear valued Dionics-USA Incorporated customer,

Dionics-USA Incorporated (hereafter referred to as Dionics-USA) is dedicated to serving you by providing high quality relays, integrated circuits, display drivers and semiconductor products that meet environmental regulations, including RoHS 3 (Restriction of Hazardous Substances) Directive, EU Directive 2011/65/EU (and subsequent amendments), the People's Republic of China requirements for concentration limits of certain hazardous substances in Electronic Information Products (China RoHS 2 - Standard SJ/T 11364-2014), and REACH (Registration, Authorization and Restriction of Chemicals, European Union Regulation (EC) 1907/2006). We are providing you the following information to assist you in meeting your environmental policies and procedures.

All parts that Dionics-USA supplies to you contain hazardous materials below the threshold in RoHS and REACH legislations with few exceptions as noted below.

The environmental regulations change constantly. We will try our best to keep you abreast of changes that affect Dionics-USA products by periodically updating this letter.

### RoHS Compliance

Dionics-USA Incorporated has been producing parts that are RoHS compliant for the last several years.

A majority of Dionics-USA products are RoHS compliant.

All of our capacitor, diode, opto and transistor bare die products are RoHS compliant.

All of our mosfet driver and display driver pdip products are available as RoHS compliant products and are marked with an "R" after the date code to signify the RoHS compliance.

All of our relays are RoHS compliant

with the exception of the DIH-126, DIH-127, DIH-128 and DIH-136 product lines.

The DIG-1115-SM/DIG-2115-SM products are RoHS compliant except when requested with tinned (Sn/Pb) leads.

RoHS COMPLIANT means that the substances restricted by the RoHS Directive (EU Directive 2002/95/EC and subsequent amendments) are not contained in a finished product above threshold limits unless the restrictive substance is subject of an exemption contained in the RoHS Directive.

Dionics-USA cannot guarantee that inventory held by distributors or other third parties is RoHS compliant.

Certain customers require parts that are not RoHS compliant.

Dionics-USA produces these parts but their manufacturing, storage and handling is completely segregated from the RoHS compliant parts to minimize contamination of the RoHS compliant products.

The compliance of Dionics-USA Incorporated products with RoHS is affected through:

- Strictly controlling the materials and finishes that are used in our products
- Periodic audits of our suppliers to insure compliance
- Periodic analysis, on an as-needed basis, of our products.


## REACH Compliance

In June 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) entered into force. This Regulation establishes specific duties and obligations on companies in the European Union (EU) that manufacture or import substances on their own, in preparations, or in articles.

Under the structure of the REACH Regulation, Dionics-USA Incorporated is a manufacturer and supplier of “articles” to our EU customers. We do not manufacture or supply “substances” or “preparations” and our articles do not involve the “intentional release of substances”. Accordingly, we foresee no registration or pre-registration requirement for the products we supply to you.

- Dionics-USA believes that even though REACH is an EU regulation, the Dionics-USA products are affected in all geographical regions. Therefore, Dionics-USA has put together a global team to implement REACH on a worldwide basis.
- Dionics-USA is constantly monitoring the substances of very high concern (SVHC), as defined by REACH, in our products. This will be an on-going process since the complete list of SVHCs will be released in stages.
